

# FREDERICK CO. FIRE & RESCUE VOLUNTEER POINT SHEET

## *Personal Property Tax Exemption and Length of Service Report Form*

In accordance with Section 58.1-3506 of the Code of Virginia, as amended, the Frederick County Board of Supervisors has declared that one vehicle owned by a volunteer rescue squad or volunteer fire department member shall constitute a separate class of property from other classifications in order that the Board of Supervisors may levy a tax on such property at a different rate than the tax levied on other tangible personal property. The one vehicle so classified must be owned by the Fire and Rescue Volunteer.

*Individual eligibility requirements established by the Volunteer Fire and Rescue Association are:*

- All members shall have at least one full year of membership with their company.
- All members shall have a vehicle registered in Frederick County, Virginia to receive the free vehicle decal.
- All members shall meet the minimum criteria of 50 points earned per year for active status and 30 points per year for semi-active status (semi-active refers to a frozen participant in the VIP).
- All members residing outside of Frederick County will receive credit for a service year upon completion of this form for LOS and VIP programs.
